

Terms and conditions – BAME COVID-19 Impact Survey Competition

OAK Community Development Ltd (“OAKCD”) is operating the competition on the basis of the following rules.

1. The competition is open to anyone residing in the borough of Oldham who completes the ‘COVID-19 Impact Survey’ from Monday 12th June 2020 until Friday 17th July. There is no other route of entry and there will be three winners.
2. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions. Entry into the Competition will be deemed as acceptance of these terms and conditions.
3. Only one entry will be permitted per [person or household]. Multiple entries from the same person or household will be disqualified.
4. All correct and eligible entries will be entered into the competition received before the closing date (12pm 17th July 2020). After this date no further entries will be permitted.
5. OAK CD will not accept responsibility for entries not received for whatever reason.
6. There are three prizes of £50 shop2love vouchers or equivalent in total. The prizes are not transferable, redeemable for cash or exchangeable for any other prize. OAK CD will not be liable for any personal injury or loss which may occur from the use of any prize.
7. The OAK CD will not be responsible for any inaccurate prize details supplied to any entrant by any third party connected with this competition.
8. You may not copy, reproduce, create or submit work that has been created and or submitted by another entrant or belonging to another individual (where permission is required from the individual and has not been obtained or granted).
9. The winners will be selected at random.
10. The identity of the winner will be ascertained by the OAK CD using their address which will need to be included, along with a valid email address and contact number.
11. The winner will be notified by OAK CD by email or phone within 14 days of draw.
12. If any of the winners cannot be contacted or do not confirm acceptance of the prize within 30 days of notification, or if it is found that a winner is ineligible,

then the winner will be considered to have forfeited the prize and the OAK CD will refer to the reserve list.

13. The winner will receive their prize within 30 days of acceptance of the prize.
14. The OAK CD will not be responsible for undeliverable, lost, delayed or misdirected email or mails regarding the Competition.
15. The name of the winner will be available in writing from the OAK CD 60 days after the judging.
16. The winner agrees to the use of his/her name in any publicity material, as well as their entry. Any personal data relating to the winner or any other entrants will be used solely in accordance with current United Kingdom data protection legislation and will not be disclosed to a third party without the entrant's prior consent.

The OAK CD will not be liable in any way if an entrant enters the competition unlawfully or violate the terms or uses harassing or threatening behaviour and such entrants will be considered to be ineligible. In the event that it is determined that an ineligible entrant wins a prize, the OAK CD reserves all rights to the ownership and return of the prize and all costs associated with remedying any prize award to an ineligible entrant.
